

AFFORDABLE CARE ACT (OBAMACARE)

We are pleased to be authorized agents of BlueCross BlueShield of Tennessee. BlueCross offers numerous plans on the marketplace that allow you to apply for Federal help in paying your premiums. Below you will find the income guidelines that determine if you qualify for premium tax credit. If your income doesn't exceed these limits then you need to apply for an "On Marketplace" plan.

In order for us to be your agent, when you get to the place where it asks if you were assisted in the enrollment process (screen snapshot below)- you will then select Agent/Broker and enter Bobby Cogdell for the agent name. You will list bobbycogdell (all lowercase and one word) in the FFM User ID. Finally, you will list the Nation Producer Number as 5931299 in the NPN box.
